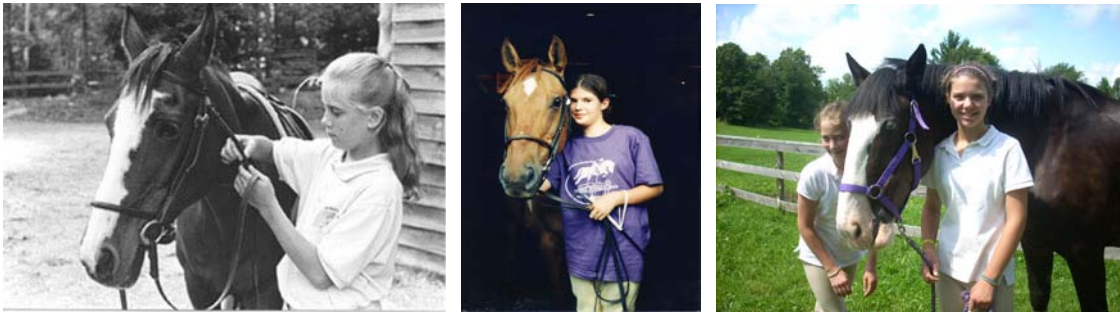


HORSE CLUB!

The Vershire Riding School introduces our HORSE CLUB! The Horse Club is for girls and boys, ages 6 and up, to learn about horses (and ponies!) through hands-on experience. Our wonderful school horses give children the opportunity to learn about horses in a safe and positive environment.

Students learn the proper care of a horse through grooming and caring for the horses overall wellbeing. Students also learn about tack, horse anatomy, horse breeds, styles of riding and more. Horse Club sessions may include demonstrations from professionals in the field.

Students gain confidence and responsibility by taking care of their horse. Everyone in the club will get experience helping with daily chores in the horse barn. This club may be your first introduction to horses, or maybe you have one of your own. The activities are geared for all abilities.

Riding lessons may be scheduled separately. Members of the Horse Club receive a \$5.00 discount off of their first scheduled riding lesson!

Club Specifics and a few general rules:

1. All students must wear boots in the barn and around horses. No open toed shoes or sandals!
2. The club is open to boys and girls 6 years of age and older.
3. Tuition is \$90.00 for the 6 meeting session.
4. Students will be dropped off at the starting time of the Club and then picked up promptly at departure. Time: 10:00 am-12:00.
5. Wear layered warm clothing! The barn can be chilly, but you will warm up quickly! It is good to have a change of clothes.
6. A snack will be served at every Horse Club meeting.
7. Work quietly around horses. No running, yelling or loud "horse play" in the barn or around horses.
8. **No one is allowed in the barns or pastures without a counselor!**
9. The Club reserves the right to end a student's membership in the Club at anytime during the session.
